1. UPLOADING OF TENDER NOTICE & TENDER DOCUMENT:-

Tender Notice for "Procurement of Office Uniforms on item wise basis for staff members of High Court of Sindh, Karachi" was published in newspapers under ID INF-KRY No. 206/2023 and also uploaded on the official website of High Court of Sindh, Karachi and SPPRA on 1st February, 2023.

2. TENDER OPENING:-




