#### Remarks:-

- 1. It is clearly mentioned in tender document that Dealership Certificate of the product which is being offered to Sindh High Court is mandatory requirement otherwise complete tender shall be rejected. M/s. Pros Link has provided "Letter of Authorization" dated 23-02-2021 issued by M/s. SY Office automation Pvt Ltd mentioning thereon that they authorized M/s. Pros Link to participate in tender on their behalf. Further, M/s. Pros Link has offered "Kyocera" brand Photostat Machines but Purchase Orders of "Sindoh" brand have been provided. From the perusal of the available record, it appears that M/s. Pros Link does not hold Dealership Certificate of "Kyocera" which is being offered to Sindh High Court.
- 2. At-least six (06) Purchase Orders were required but M/s. Pros Link has provided only four (04) Purchase Orders. Purchase Order No. 5377 dated 13-07-2020 issued from State Bank of Pakistan for supply of two (02) units of Sindoh Model M-612 has been quoted twice at page # 9 of tender document and two copies of the said Purchase Order and two different delivery challan # 16 & 19 dated Nil-11-2020 have been provided. Perhaps the supplier has tried to manipulate the documents in order to complete the requirement of Purchase Orders.
