It was clearly mentioned in the eligibility criteria (page-No. 8 of tender document) that *Purchase orders without proof of delivery challans of the relevant Purchase Orders shall not be considered.* Further, it was also mentioned at page-No6 of tender document that bids submitted without copies of the mandatory documents will be rejected without consideration being non-responsive. Despite clear directions. M/s. Amisco has not furnished delivery challan of the relevant Purchase Order.

After issuance of the technical Bid Evaluation Report, M/s. Amisco vide letter dated 11-06-2021 stated that they accepted the above mentioned eligibility criteria that Purchase Orders would not be considered without delivery challan. Further, they accepted that they did not submit delivery challans at the time of submission of bid and requested to accept the delivery challan furnished along with the letter dated 11-06-2021 submitted after issuance of the report. The Committee examined the contents of the said letter and rejected the same being violation of rules.

4. Technical Evaluation Report:-

Both eligibility qualified bidders i.e. M/s. AddWise Supplies & Services and M/s. Shaheer Traders have quoted same model i.e. Mitsubishi Model No. MS-C18VC for all lots i.e. 1 to 6.

- 2) M/s. Amisco could not qualify the eligibility criteria as it did not furnish the delivery challans which were mandatory.
- 3) M/s. Add Wise Supplies & Services and M/s. Shaheer Traders qualified the eligibility and technical criteria and offered Mitsubishi Model No. MS-C18VC for all lots.
- 4) Technical Bid Evaluation Report was uploaded on the official website of this Court on 9th June, 2021.
- 5) Financial Proposals of qualified bidders i.e. M/s. Add Wise Supplies & Services and M/s. Shaheer Traders were opened on 15th June, 2021 at 11:30 a.m.
- 6) M/s. Shaheer Trader offered Rs. 143,840/= (with GST) for one (01) unit of 1.5 Ton Split A.C (Mitsubishi MS-C18VC) along with Stac Stabilizer 7000 watts including installation, transportation etc.
- 7) M/s. Add Wise Supplies & Services offered Rs. 166,791/= (with GST) for one (01) unit of 1.5 Ton Split A.C (Mitsubishi MS-C18VC) along with Universal Stabilizer 7000 watts including installation, transportation etc.
- 8) M/s Shaheer Trader is the lowest bidder in all the lots in tender for procurement of Split A.Cs for Judicial Complex Korangi, Karachi.
