

# HIGH COURT OF SINDH KARACHI

No. 1099/Conf:VI-Z-23(83)JM-DP

## O R D E R

*WHEREAS*, the Show Cause Notice bearing No.496/Conf:VI-Z-23(83)JM-DP, dated 17.6.2013 under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the grounds of 'inefficiency' and 'corruption' was served upon Ms. Aliya Malik, Civil Judge & Judicial Magistrate, reply thereof was furnished by her on 3.7.2013.

*AND WHEREAS*, the Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, had come to the conclusion that he is guilty of charge leveled against her and liable to impose one of the major penalties prescribed under Rule 4(1)(b) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him. As such Final Show Cause Notice bearing No.460/Conf:VI-Z-23(83)JM-DP, dated 19.5.2015 was served upon the delinquent Officer, reply thereof was furnished by her on 18.6.2015.

*AND WHEREAS*, the Hon'ble Authorised Officer, while going through the facts as well as circumstances of the matter and giving an opportunity of personal hearing to the delinquent Officer, has come to the conclusion that she is guilty of the charge leveled against her and recommended that the major penalty of '*compulsory retirement*' as prescribed under Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, be imposed upon the delinquent Officer.


*AND WHEREAS*, the Hon'ble Chief Justice/Authority, after considering the facts as well as circumstances of the matter and hearing the delinquent Officer in person has decided, in exercise of powers under clause (b) of Sub-Rule (4) of Rule 5 of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, to impose major penalty of '*compulsory retirement*' as prescribed under Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon Ms. Aliya Malik, Civil Judge & Judicial Magistrate.


