## **NOTIFICATION**

In continuation of this Court's Notification dated 25<sup>th</sup> September, 2025 (copy enclosed) and in compliance with the minutes of 54<sup>th</sup> meeting of the National Judicial (Policy Making) Committee on Agenda # 2 Institutional Response to Extraneous Influence on Judicial Officers of District Judiciary held on 18<sup>th</sup> August, 2025, the Hon'ble Acting Chief Justice has been pleased to order that the Judicial Oversight Cell shall be responsible for:

- I. Receiving complaints of extraneous influence from judicial officers.
- II. Conducting inquiries/investigations into such complaints in a discreet and effective manner.
- III. Submitting reports and recommendations to the Honourable Chief Justice for appropriate action.

### Maintenance of Records and Periodic Reporting:

The Judicial Oversight Cell shall maintain a detailed record of all complaints received, the nature of each complaint, the process and outcome of inquiries, and the action taken.

a) A consolidated quarterly report summarizing the number of complaints, their nature, and the outcomes, shall be submitted to the LJCP Secretariat in compliance with the prescribed requirements.

#### Confidentiality and Protection:

The mechanism shall ensure complete confidentiality of complainants and witnesses. Judicial officers submitting complaints shall be protected from any adverse consequences or retaliation.
