ORDER

In continuation of this Court's order of even number dated 02.03.2017, the Hon'ble Chief Justice by exercising the powers conferred under Notification No. BI/2(18)/1996 dated 26.11.1996 of Finance Department, Government of Sindh and Rule 4 of Sindh High Court Establishment (Appointment and Conditions of Service) Rules, 2006, has been pleased to approve the formula of "Incentive of Next Higher Scale on the basis of Time Scale" to the following posts of the Establishment of Sindh High Court, Principal Seat at Karachi, Bench at Sukkur and Circuit Courts at Hyderabad & Larkana from the date of their initial appointment in this Court on completion of prescribed length of satisfactory service in their respective post, as detailed hereunder:-

It is also ordered that for the posts of Head Bailiff and Garden Supervisor, the service will be reckoned from the incumbent's initial appointment in this Court as Bailiff and Gardener respectively.
