

**THE HIGH COURT OF SINDH KARACHI**

**O R D E R**

**WHEREAS**, the Show Cause Notice bearing No.858/Conf:VI-Z-23(2)JM, dated 27<sup>th</sup> August, 2009 was served upon Mr. Muhammad Shujaat Mirza, Civil Judge & Judicial Magistrate, under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the ground of “**corruption**” and reply thereof was furnished by him in due course of time.

**AND WHEREAS**, the Authorised Officer after giving an opportunity of personal hearing to the delinquent officer on 07.5.2010 and perusing the record, has come to the conclusion that he is guilty of the charge levelled against him and recommended for imposition of one of the major penalties prescribed in Rule 4(1) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him. As such, Final Show Cause Notice bearing No.880/Conf:VI-Z-23(2)JM dated 16.7.2010 was served upon him and reply thereof was furnished by him in due course of time.

**AND WHEREAS**, the Hon'ble Authorised Officer after giving an opportunity of personal hearing to the delinquent officer on 12.3.2016 and going through the facts of the matter, has come to the conclusion that he is guilty of the charge and recommended that major penalty of ‘**compulsory retirement**’ prescribed in Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 be imposed upon him.

**AND WHEREAS**, the Hon'ble Chief Justice/Authority, after considering the facts of the matter and affording an opportunity of personal hearing to the delinquent Officer on 08.10.2016, in exercise of the powers conferred upon him under Rule 5(4)(b) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, has decided to impose major penalty of ‘**compulsory retirement**’ upon him.

**NOW THEREFORE**, the penalty of 'compulsory retirement' under Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed upon Mr. Muhammad Shujaat Mirza, Civil Judge & Judicial Magistrate, with immediate effect.
