*AND WHEREAS*, the Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, had come to the conclusion that she is guilty of charge leveled against her and liable to impose major penalty of '**dismissal from service**' prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon her. As such Final Show Cause Notice bearing No.560/Conf:VI-Z-23(356), dated 11.6.2015 was served upon the delinquent Officer, reply thereof was furnished by her on 18.6.2015.


