



#### NOTE:

- a) The District & Sessions Judges are entitled to (15) days' vacation.
- b) The Additional District & Sessions Judges who have earned the required units are entitled (15) days' vacation. The Additional District & Sessions Judges who have not earned the required units are allowed to avail (10) days summer vacation, as a special case.
- c) The Additional District & Sessions Judges, Senior Civil Judges and Civil Judges/Judicial Magistrates who have less than one-year service are not entitled to any vacation.
- d) The Senior Civil Judges and Civil Judges/Judicial Magistrates who have earned the required units are entitled to vacation for two weeks. Those Senior Civil Judges and Civil Judges & Judicial Magistrates who have not earned the required units are entitled to (10) days summer vacation, as a special case.



**ORDER**


The Hon'ble Chief Justice is pleased to allow Summer Vacation for 15 days to all the officers/officials of this Court, Sukkur Bench and Circuit Courts Hyderabad and Larkana, subject to the following conditions:-

1. The staff members shall be entitled to summer vacation to the extent of 15 days. The vacation, if availed, would be subject to adjustment to the extent of 2/3 against earned leave.
2. Summer Vacation will be availed-of from second week of the vacation and end one week before its expiry.
3. The officials, who have not put in full year of service, will not be entitled to it.
4. Summer Vacation may be availed by the staff members working in the Branches / Offices subject to approval of the learned Registrar.
5. Staff of the Hon'ble Judges may avail vacation subject to the approval of the Hon'ble Judges whom they are attached with.
6. The Officers of this Court shall proceed on summer vacation in co-ordination with their alternate as referred in this Court's Order No.Gaz/XII.Z.14(HC)(i) dated 05-01-2012 under intimation to Gazette Branch otherwise their summer vacation will not be considered.
7. It should be ensured that sufficient staff is available in each Branch / Office / Court Room to cope up with the work during summer vacation. Substitutes of the staff recommended to avail vacation will not be provided.
