LOT NO. 2: PROCUREMENT OF FURNITURE AND FIXTURES

■ 1. Introduction

The procurement process for Lot No. 2: Furniture and Fixtures for the High Court of Sindh, Karachi, was initiated to support the smooth operation of the Court's administrative and judicial functions. The procurement was carried out through Open Competitive Bidding (Single Stage – One Envelope Procedure) in accordance with the Sindh Public Procurement Rules, 2010 (SPPRA). The tender was publicly opened on Saturday, May 31, 2025 at 11:00 a.m. in the office of the Director General (Finance and Accounts) at the High Court of Sindh, Karachi.

Two bidders participated in this process: M/s Fast Link Supply Agency and M/s Al Mustafa Pak Traders, who submitted their bids for Lot No. 2: Procurement of Furniture and Fixtures.

■ 7. Final Recommendations

✓ Recommended Bidder for Award:

- M/s Al Mustafa Pak Traders is the lowest evaluated, responsive, and compliant bidder for Lot No. 2: Procurement of Furniture and Fixtures, with a total bid amount of Rs. 5,326,000 (inclusive of all taxes).

✗ Non-Responsive Bidder:

- M/s Fast Link Supply Agency is non-compliant due to failure to submit the Manufacturer/Authorization Letter, as per the mandatory eligibility criteria.
