


3. Observations

- **Price Comparison:**
M/s Mansha Brothers' quoted price is lower by **PKR 1,608,515.75** compared to M/s Syed Business Solutions for the same quantity and scope.
- **Delivery Timeline:**
M/s Mansha Brothers offers **immediate availability (Ex-Stock)** in Karachi, whereas M/s Syed Business Solutions' equipment is **Ex-Stock in Dubai**, with a **4-week lead time**.
- **Bid Security Compliance:**
Both bidders have submitted valid bid securities. M/s Syed Business Solutions submitted a higher-than-required amount, indicating financial readiness.
- **Product Clarity:**
M/s Mansha Brothers has provided a specific product model (Yealink MB86-A001), ensuring transparency. M/s Syed Business Solutions did not specify a model, referencing compliance in the technical proposal, which may affect evaluation clarity.

4. Recommendation

Based on the financial evaluation and subject to technical compliance, it is recommended to **award the contract to M/s Mansha Brothers**, who is the **lowest financially responsive bidder** offering the most economical and prompt solution for the procurement and installation of the Smart LED Display with interactive features for the Committee Room, Sindh High Court.

3. Evaluation Summary

- Both bidders meet the technical requirements and have submitted valid financial bids.
- M/s Syed Business Solutions submitted the lowest evaluated bid at PKR 1,312,750, which is PKR 162,250 less than the bid by M/s IT Republican.

4. Recommendation

It is recommended to award the contract to M/s Syed Business Solutions for Lot No. 6, based on the lowest responsive bid of PKR 1,312,750, inclusive of all taxes.



