1. Introductory Paragraph

The procurement process for Lot No. 11: Supply and Installation of Digital Duplicator/Copy Printer (On Ex-Stock Basis Only) was initiated to facilitate the High Court of Sindh's operational requirements for efficient document processing and reproduction. The tender was conducted through Open Competitive Bidding (Single Stage – Two Envelope Procedure), in accordance with the applicable rules and regulations, including the Sindh Public Procurement Rules, 2010 (SPPRA). The tender was publicly opened on Saturday, May 31, 2025, at 11:00 a.m., in the office of the Director General (Finance & Accounts), High Court of Sindh, Karachi.

6. Rule 48: Acceptance of Bids

It is important to mention that only a single bidder participated in the tender for Lot No. 11. Consequently, this office obtained additional market quotations for rate comparison. Upon thorough evaluation and in accordance with the relevant rules, the rates quoted by the qualified bidder for the subject tender were found to be comparable with prevailing market rates.

7. Conclusion and Recommendation

Based on the evaluation of the Mandatory Qualification/Eligibility Criteria, Technical Specifications, and Financial Bid, M/s O & A Business Machines (Pvt.) Ltd. has been found to be Technically Responsive and Financially Lowest Evaluated Bidder (LEB) for Lot No. 11.

It is recommended to award the contract for Lot No. 11: Supply and Installation of Digital Duplicator/Copy Printer to M/s O & A Business Machines (Pvt.) Ltd. at their quoted price of Rs. 1,225,000/- (inclusive of all taxes).
