





1. Uploading of Tender Notice & Tender Document:-

Tender Notice and Tender Document for “**Procurement of Office Uniforms for staff members of High Court of Sindh, Karachi**” were uploaded on the official website of Sindh High Court as well as on official website of SPPRA on 7th April, 2022.

2. Details of Bidder participated in Tender:-

Only two (02) bidders i.e. M/s. Hassan Enterprises, Hyderabad and M/s. Murtaza Enterprises, Hyderabad participated in the subject tender as reflected in Attendance Sheet. All bids were sealed & received on time.

3. Tender Opening:-

No objections were received on tender documents, eligibility criteria, specifications, terms & conditions and tender proceedings from any corner. Tender was opened in public on 25th April, 2022 at 10:30 a.m., in the presence of Chairman, Members of Bid Evaluation Committee and representatives of bidders as reflected in Attendance Sheet.

4. Evaluation of Eligibility Criteria:-

All bids were evaluated on the basis of already defined eligibility criteria as mentioned below:





5. Observations:-

1. Both bidders failed to submit tender documents which were the main requirement for participating in the subject tender.
2. Copies of GST, NTN and SRB Registration certificates were not furnished by the above named bidders.
3. M/s. Hassan Enterprises has not furnished delivery challans while M/s. Murtaza Enterprises has not furnished both Purchase Orders & Delivery Challans.
4. The above named bidders have not furnished income tax returns / Audited statement of Accounts so that their financial capabilities can be evaluated.
5. The Committee observed that both bidders participated in tender in very casual manner and failed to furnish the required documents. The above mentioned facts were also brought into the knowledge of the above named bidders but they failed to submit reasonable justification of non-availability of duly signed & stamped tender documents and copies of the required documents.
6. It was mentioned under terms & conditions of tender document that substantially responsive Bid is one that conforms to all the terms, conditions, and specifications of the Bidding Documents without material deviation, reservation, or omission. Non-responsive Bids shall not be considered. Bidders are advised in their own interest to prepare their bids as per format, requirements, terms & conditions, mentioned in bid documents.

6. Conclusion:

After deliberate discussion and considering all the fact as mentioned above, the bids submitted by the above named bidders are rejected as per rules.
