SUBJECT: - POLICY AND PROCEDURE FOR NOMINATION OF CANDIDATES (BENEFICIARIES) FOR ADMISSION AGAINST AL-MIZAN FOUNDATION'S SEATS IN MEDICAL AND ENGINEERING COLLEGES OF ISLAMIC INTERNATIONAL MEDICAL COLLEGE TRUST.

Dear Sir,

I am directed to state that there is an agreement between Al-Mizan Foundation and Islamic International Medical College Trust (hereinafter referred to as "the Trust"), Clause 8 whereof relevant to the subject nomination reads as under: -

- "8. The Trust shall also provide to the Al-Mizan Foundation's recommended beneficiaries one seat annually in its Medical and Engineering Colleges with full admission and tuition fee waiver. Selection of a candidate for admission from amongst the recommendees of the Foundation shall be in the discretion of the competent authorities of the Trust, keeping in view the standards prescribed by the PMDC".
- 2. Whereas according to Memorandum and Articles of Association of Al-Mizan Foundation, the "beneficiaries" mean citizens of Pakistan who have served in the Superior Judiciary and who have served or are serving in the subordinate Judiciary, in the establishments of superior courts, subordinate courts, including their dependents and the dependents of deceased beneficiaries.
- 3. The Committee of Administration in its meeting held on 3rd February, 2010 while making Policy regarding nomination of the eligible candidates (beneficiaries) for admission in Medical and Engineering Colleges of the Trust against Al-Mizan Foundation's seats, decided that in the coming year selection/ nomination will be made on rotation basis in alphabetical order starting from the Province of Balochistan.
- 4. Whereas in order to implement the aforesaid Policy in letter and spirit, the Committee of Administration in its meeting held on 30.03.2011 has approved the following Procedure with respect to such nomination: -
  - (a) The Selection/ nomination of candidates against the reserved seats in the Colleges of the Trust shall be made by the Committee of Administration of Al-Mizan Foundation from amongst the eligible candidates on merit of the respective Province. The decision of the Committee of Administration shall be final.
    - (b) The unclaimed seat of the respective Province, if any shall be given to the candidates of the Province coming in the next alphabetical order.
    - (c) The candidates seeking admission to Colleges of the Trust shall have to send their applications through respective Registrars to the Al-Mizan Foundation for onward transmission to the Trust.



(d) The applications are required to be submitted in the duplicate along-with copies of required documents before the date specified in the advertisement, broadcast/television etc. by the Trust.

The Committee of Administration of Al-Mizan Foundation reserves the right of making any addition, alteration or amendment in the nomination policy at any time."

5. The allocation of seat for the province of Balochistan having already been done in the year 2011, the said province shall not be considered in the next admissions for 2012, the Committee also decided in the said meeting.

I am further directed to request you to circulate the contents of this letter for the information of concerned beneficiaries and further action accordingly.
