## CIRCULAR

In wake of fresh wave of COVID-19 and rapid increase in number of asymptomatic patients in the Country and in continuation to the circular dated 25<sup>th</sup> November, 2020 issued in pursuant to the decision of Hon'ble Administration Committee of this Court taken in its meeting held on 17<sup>th</sup> November, 2020 that the High Court of Sindh, Principal Seat at Karachi, its Bench at Sukkur and Circuit Courts at Hyderabad and Larkana as well as District Judiciary and all other Ex-Cadre Courts/Tribunals working under the Administrative Control of High Court of Sindh shall forthwith implement the protocol/instructions/precautionary measures as expressed/enunciated inter alia in above noted circular are issued herewith for the convenience and implementation in letter and spirit:-

- 1. All the Courts Officials and the officials of law enforcement agencies posted at the main gate entrance of the Courts shall wear face masks, use hand sanitizer and avoid handshake.
- 2. Every person entering the Court premises/precincts including the security officials and staff member of the Courts shall be scanned properly with temperature scanners/thermal guns at the time of their entrance. In case temperature of any one found not normal or found to have symptoms of Corona, he shall not be permitted to enter in the Court's premises.
- 3. In every Courtroom/Branch/Office hand sanitizers shall be made available and the ventilators, windows and gates shall remain open for proper cross ventilation.
- 4. Necessary arrangement for fumigation/disinfection of floors and surfaces with disinfectant material shall be made in all the Chambers, Court rooms, Offices and Branches on routine basis. The other offices situated in the Court premises shall also ensure compliance of this direction in their respective offices.

allowed to enter in Courtrooms and the parties whose presence is necessary or required to appear before the Affidavit and Identification section of the Court for the purpose of swearing affidavits will only be allowed to enter in the Court premises and Court room with face mask.

- All lawyers/parties/officials, whose cases have not been fixed for the 6. day should better avoid coming to the Court premises in order to keep from overcrowding and for safety and security of the general public, staff and Judges of the Courts.
- 7. All the officers and staff members of the Courts and employees of other Departments situated in Court premises shall mandatory wear mask. wash hands upon arrival & prior joining their work place and they shall not shake hands or make physical contact or embrace each other for greetings or participate in gatherings including sitting in groups during office hours.
- Any Employee whose immediate family member living jointly has 8. been infected by Coronavirus shall immediately inform the concerned authority for further necessary action.
- All the Court Associates/Incharge of Branches/Officers are directed 9. to ensure that all the precautionary measures set out shall be scrupulously followed in their respective Courts/Branches/Offices in letter and spirit.
