And Recording of evidence, arguments and final disposal

Note: Those matters should be fixed and heard on priority basis in which stay/status quo or any restraining order(s) is operating.

NOTE:

- 1) Cases which cannot be fixed before D.B-I, will be fixed before D.B-VI, and vice versa and Cases which cannot be fixed before DB-I and D.B-VI will be fixed before DB-V. Cases which cannot be fixed before DB-II will be fixed before DB-IV, and Vice Versa and cases which cannot be fixed before DB-II and DB-IV will be fixed before DB-III. Cases which cannot be fixed before DB-III will be fixed before DB-V, and Cases of D.B-III, which cannot be fixed before DB-V, will be fixed before DB-IV. Cases which cannot be fixed before D.B-V will be fixed before D.B-VI, and Cases of D.B-V, which cannot be fixed before DB-VI, will be fixed before DB-I.
- 2) Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (OS-I). Cases which cannot be fixed before (OS-I) will be fixed before (OS-II) and Vice Versa and Cases which cannot be fixed before (OS-I) and (OS-II) will be fixed before (OS-III). Cases which cannot be fixed before (OS-III) will be fixed before (OS-II), and cases of (OS-III) which cannot be fixed before (OS-II) will be fixed before (OS-I). Similarly Cases which cannot be fixed before SB-I (AS) will be fixed before SB-II (AS) and Cases of S.B-I (AS), which cannot be fixed before S.B-II (AS), will be fixed before S.B-III (AS). Cases which cannot be fixed before S.B-II (AS) will be fixed before SB-III (A.S) and Vice Vera, and Cases which cannot be fixed before SB-II (AS) and SB-III (AS), will be fixed before SB-I (AS).
- 3) Cases which cannot be fixed before the Hon'ble Judges sitting at appellate side will be fixed before senior most Judge of original side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at original side will be fixed before senior most Judge of appellate side.
- 4) Commercial Cases will be given priority over the other matters.
- 5) Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Adnan Iqbal Chaudhry.
- 6) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench as per direction of Hon'ble Chief Justice.
- 7) In case for any reason, case (s) which cannot be fixed before any D.B, the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
- 8) All Permissions in the Cases may be obtained in pursuance of Circular No. GAZ/XII.Z.14(HC)(III) Karachi dated 21.08.2021.

Note: Those matters should be fixed and heard on priority basis in which stay/status quo or any restraining order(s) is operating.

NOTE:

1. Cases which cannot be fixed before D.B-I, will be fixed before D.B-VI, and vice versa and Cases which cannot be fixed before DB-I and D.B-VI will be fixed before DB-V. Cases which cannot be fixed before DB-II will be fixed before DB-IV, and Vice Versa and cases which cannot be fixed before DB-II and DB-IV will be fixed before DB-III. Cases which cannot be fixed before DB-III will be fixed before DB-V, and Cases of D.B-III, which cannot be fixed before DB-V, will be fixed before DB-IV. Cases which cannot be fixed before D.B-V will be fixed before D.B-VI, and Cases of D.B-V, which cannot be fixed before DB-VI, will be fixed before DB-I.
2. Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (OS-I). Cases which cannot be fixed before (OS-I) will be fixed before (OS-II) and Vice Versa and Cases which cannot be fixed before (OS-I) and (OS-II) will be fixed before (OS-III). Cases which cannot be fixed before (OS-III) will be fixed before (OS-II), and cases of (OS-III) which cannot be fixed before (OS-II) will be fixed before (OS-I). Similarly Cases which cannot be fixed before SB-I (AS) will be fixed before SB-II (AS) and Cases of S.B-I (AS), which cannot be fixed before S.B-II (AS), will be fixed before S.B-III (AS). Cases which cannot be fixed before S.B-II (AS) will be fixed before SB-III (A.S) and Vice Vera, and Cases which cannot be fixed before SB-II (AS) and SB-III (AS), will be fixed before SB-I (AS).
3. Cases which cannot be fixed before the Hon'ble Judges sitting at appellate side will be fixed before senior most Judge of original side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at original side will be fixed before senior most Judge of appellate side.
4. Cases under various acts, contempt of Court cases received from the subordinate courts, Bail before arrest and matters relating to transfer of cases will be fixed on Monday(s) as per direction of Honourable Chief Justice.
5. Commercial Cases will be given priority over the other matters.
6. Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Adnan Iqbal Chaudhry.
7. Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench as per direction of Hon'ble Chief Justice.
8. In case for any reason, case(s) which can not be fixed before any D.B., the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
9. All Permissions in the Cases may be obtained in pursuance of Circular No. GAZ/XII.Z.14(HC)(iii) Karachi dated 21.08.2021.


