Cases which cannot be fixed before (OS-IV) will be fixed before (OS-II) and cases of (OS-IV) which cannot be fixed before (OS-II) will be fixed before (OS-III). Similarly cases which cannot be fixed before S.B-I (AS) will be fixed as per direction of Honourable Chief Justice. Cases which cannot be fixed before S.B-II (AS) will be fixed before S.B-III(AS) and vice versa and cases which cannot be fixed before S.B-II (AS) & S.B-III (AS) will be fixed before S.B-V(AS). Cases which cannot be fixed before SB-IV (AS) will be fixed before SB-V (AS) and cases of SB-IV (AS) which cannot be fixed before S.B-V (AS) will be fixed before SB-III (AS). Cases which cannot be fixed before SB-V (AS) will be fixed before SB-II (AS) and cases of SB-V (AS) which cannot be fixed before S.B-II (AS) will be fixed before SB-III (AS). - 6) Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Nazar Akbar, hence Hon'ble Mr. Justice Nazar Akbar is abroad, during his absence Hon'ble Mr. Justice Amjad Ali Sahito has been nominated temporarily for said Cases of Special Appellate Court (Custom & Taxation).
- 7) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench as per direction of Hon'ble Chief Justice.
- 8) General Adjournments of Learned Advocates will not be allowed in Special Benches constituted on Original Sides.
- 9) Cases / matters on Appellate Side (SB) in which urgent permission is required to be sought may be obtained / granted by Honourable Senior Judge as "J-I" in case of non availability of Hon'ble J-I, the next respective Senior Hon'ble Judge of S.B. (A.S.) of Civil and Criminal Bench(es) respectively will give said permission except matters pertain to the jurisdiction of Honourable Chief Justice.
